3. Bidders shall submit their proposals only through PPRA EPAD system.
4. All bids must be accompanied by a Bid Securing Declaration as per attached form in Standard Forms Section of this bidding document.
5. Bid properly filled in must be submitted online on EPADS, before 17<sup>th</sup> March 2026 at 1330 Hrs. Bids will be opened through EPAD system on same day at 1100 Hrs thereafter in public and in presence of bidders' representatives who choose to attend in opening at Room No. 11, Ground Floor, PTA HQs F-5/1, Islamabad.

## A. INTRODUCTION

1. Scope of Bid	1.1	PTA, as indicated in Bid Data Sheet (BDS) invites Bids for Photocopier Machines as specified in BDS and Section V - Technical Specifications & Schedule of Requirements. successful Bidders will be expected to supply Photocopier Machines (Total Quantity= 9) including 6x Photocopier Machines as light duty and 3x Photocopier Machines as Intermediate to Heavy Duty within specified period and timeline(s) as stated in BDS.
	1.2	Unless otherwise stated throughout this document definitions and interpretations shall be as prescribed in General Conditions of Contract (GCC).
2. Source of Funds	2.1	Source of funds is referred in Clause-2 of Invitation for Bids.
3. Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in form of a joint venture, consortium, or association. In case of a joint venture, consortium, or association, all members shall be jointly and severally liable for execution of Contract in accordance with terms and conditions of Contract. joint venture, consortium, or association shall nominate a Lead Member as nominated in BDS, who shall have authority to conduct all business for and on behalf of any and all members of joint venture, consortium, or association during Bidding process, and in case of award of contract, during execution of contract. <i>(limit on number of members of JV or Consortium or Association may be prescribed in BDS, in accordance with guidelines issued by PPRA).</i>
	3.2	appointment of Lead Member in joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to PTA.
	3.3	Verifiable copy of agreement that forms a joint venture, consortium or association shall be required to be submitted as part of Bid.
	3.4	Any bid submitted by joint venture, consortium or association shall indicate part of proposed contract to be performed by each party and each party shall be evaluated (as most qualified if required) with respect to its

	3.5	invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by respective national incorporating agency or statutory body established for that particular trade or business.
	3.6	Foreign Bidders must be locally registered with appropriate national incorporating body or statutory body, before participating in national/international competitive tendering with exception of such procurements made by foreign missions of Pakistan. For such purpose bidder must have to initiate registration process before bid submission and necessary evidence shall be submitted to PTA along with their bid, however, final award will be subject to complete registration process.
	3.7	<p>A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:</p> <ul style="list-style-type: none"> <li>a) are associated or have been associated in past, directly or indirectly with a firm or any of its affiliates which have been engaged by PTA to provide consulting services for preparation of design, specifications and other documents to be used for procurement of hardware (Photocopier Machines) to be procured under this Invitation for Bids.</li> <li>b) have controlling shareholders in common; or</li> <li>c) receive or have received any direct or indirect subsidy from any of them; or</li> <li>d) have same legal representative for purposes of this Bid; or</li> <li>e) have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on Bid of another Bidder, or influence on decisions of PTA regarding this Bidding process; or</li> </ul>

	3.8	A Bidder may be ineligible if -  (a) he is declared bankrupt or, in case of company or firm, insolvent; (b) payments in favor of Bidder is suspended in accordance with judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with national laws) in total or partial loss of right to administer and dispose of its property; (c) legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with national laws, in a declaration of bankruptcy or in any other situation entailing total or partial loss of right to administer and dispose of property; (d) Bidder is convicted, by a final judgment, of any offence involving professional conduct; (e) Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration. (f) firm, supplier and contractor is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for period defined by them.
	3.9	Bidders shall provide to PTA evidence of their eligibility, proof of compliance with necessary legal requirements to carry out contract effectively.
	3.10	Bidders shall provide such evidence of their continued eligibility to satisfaction of PTA, as PTA shall reasonably request.
	3.11	Bidders shall submit proposals relating to nature, conditions and modalities of sub-contracting wherever sub-contracting of any elements of contract amounting to more than ten (10) percent of Bid price is envisaged.
4. Eligible Information Systems	4.1	For purposes of these Bidding Documents, Hardware System means all: a) required information technologies, including all information processing and communications-related hardware, software, supplies, and consumable items that Supplier is required to and install under Contract, plus all

	4.2	All Branded Photocopier Machines made up of goods and services to be supplied under contract shall have their origin in eligible source countries, and all expenditures made under contract will be limited to supply Photocopier Machines (Qty 09 of two categories). For purpose of this Bid, ineligible countries are stated in section-4 titled as "Eligible Countries".
	4.3	For purposes of this Clause, "origin" means place where goods and services making Photocopier Machines are produced in or supplied from. An hardware is deemed to be produced in a certain country when, in territory of that country, through software development, manufacturing, or substantial or major assembly or integration of components, a commercially recognized product result that is substantially different in basic characteristic or in purpose or utility from its component.
	4.4	nationality of supplier that supplies and install hardware shall not determine origin of goods.
	4.5	To establish eligibility of Goods and Services making hardware, Bidders shall fill country-of-origin declarations included in Form of Bid.
	4.6	If so required in BDS, Bidder shall demonstrate that it has been duly authorized for supply of Photocopier Machines in Pakistan (or in respective country in case of procurement by Pakistani Missions abroad), hardware System indicated in its Bid.
5. One Bid per Bidder	5.1	A bidder shall submit only one Bid, in same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
