CORRIGENDUM

Islamabad, the 2nd January, 2006

[To the *Gazette of Pakistan Extra-ordinary Part II*, dated the 24th September, 2005, containing notification No. S. R. O. 1006 (I)/2005 dated 16th August, 2005]

The Pakistan Telecommunication Authority is pleased to notify the Following amendments:—

- (i) Page 3072, Regulation 2 (d), after the Word 'and', the word 'includes' may be inserted; The amended sub-regulation may be *read* as follows:
 - (d) "APCL" means Access Promotion Contribution for fixed line Local Loop and includes Limited Mobility Communication Service or Wireless Local Loop;
- (ii) Page 3072, Regulation 2 (f), after the word 'under', the word 'rule' may be inserted; The amended sub-regulation may be *read* as follows:
 - (f) "Approved Accounting Rate" means Total Accounting Rate approved by the Authority under rule 6 of Access Promotion Rules;

- (iii) Page 3073, Regulation 2 (n), the Words 'or has the same meaning as given in other PTA Regulations' may be omitted; The amended sub-regulation may be *read* as follows:
- (n) "LDI Licensee" means a person licensed under the Act to establish, maintain and operate a public fixed switched network for the provision of nation-wide long distance and international telephony service;
- (iv) Page 3073, Regulation 2 (p), the Words 'or has the same meaning as given in other PTA Regulations' may be omitted. The amended sub-regulation may be *read* as follows:
- (p) "LL Licensee" means a person licensed under the Act to establish, maintain and operate a public fixed switched network for the provision of local exchange telecommunication service, and includes PTCL, National Telecommunication Corporation and any person licensed under the Act to provide Limited Mobility Communication Service;
- (v) Page 3073, Regulation 2 (r), the Word 'to' may be *substituted* for word 'a' appearing *for* the Fourth time, and after the word 'public' the word 'mobile' may be inserted, and lastly *for* the word 'device' the word 'service' may be *substituted*. The amended sub-regulation may be *read* as follows:
- (r) "Mobile Licensee" means a person licensed under the Act to establish, maintain and operate a public mobile switched network to provide Mobile Communications Service, but excluding a person that is licensed to provide a Limited Mobility Communication Service;
- (vi) Page 3074, Regulation 3 sub-regulation (2), *for* the word 'information', the word 'approval' may be *substituted*. The amended sub-regulation may be *read* as follows:
- (2) LDI Licensee shall submit copy of draft Agreement, duly signed by both the parties, to the Authority for approval pursuant to sub-regulation (1).
