<u>Prequalification of Security Companies for Provision of Security</u> <u>Services at PTA Zonal Office Lahore</u>

1. PTA Zonal Office Lahore intends to hire the services of a well reputed Security Company for provision of security services at PTA Zonal Office and Inspection Rooms located at Lahore Cantt for a period of three (03) years renewable on yearly basis as per detail given below:-

- 2. The services will be hired according to PPRA Single stage two envelop procedure.
- 3. Salient of single stage two envelop procedure are enumerated below:-

- a. The bid shall comprise a single package containing two separate envelops. Each envelope shall contain separately the financial proposal and the technical proposal;
- b. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion;
- c. Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened;
- d. The envelope marked as "FINANCIAL, PROPOSAL" shall be retained in the custody of the procuring agency without being opened;
- e. PTA Zonal Office Lahore will evaluate the technical proposal first without reference to the price and reject any proposal which does not conform to the specified requirements;
- f. Weightage of Technical and Financial proposals will be 70% and 30% respectively.
- g. During the technical evaluation no amendments in the technical proposal shall be permitted;
- h. The financial proposals of technically qualified bids will be opened publicly at a time, date and venue announced and communicated to the bidders.
- i. After the evaluation and approval of the technical proposal PTA Zonal Office Lahore, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders; and
- j. The bidder obtaining highest marks combining Technical and Financial proposals will be awarded the contract.

4. <u>Pre-Qualification - Mandatory:-</u>

Company must furnish following information;

- a. Valid license to operate in Punjab Province
- b. NOC issued by Punjab Government
- c. Registration with SECP
- d. Registration with Social Security
- e. Copy of NTN certificate
- f. Registration with All Pakistan Security Agencies Association (APSAA) Affidavit that the firm has not been black listed by any Government / Semi Government organization.
- g. Proof of financial soundness from a scheduled bank accompanied with bank statement for the last one year.
- h. Pay order / bank draft of 2% of total quoted price for the first year shall accompany the financial proposal as Bid Security/ Earnest money. Technical proposal must contain a certificate regarding attachment of earnest money along with financial bid. Failing to do so may result into disqualification.
- i. The successful bidder will be required to deposit a "performance/ bank guarantee" equivalent to two (2) months remuneration of the first year, through a Pay Order/ bank draft in favor of PTA within one week of award of contract. If the bidder fails to deposit performance/ bank guarantee within one week of the receipt of the letter awarding the job, the same shall be treated as cancelled and the earnest money shall be forfeited. The bid security of the successful contractor will be adjusted against the performance guarantee
- j. Deployment of at least 200 security guards in Lahore municipal limits. A certificate to this effect will be furnished along with details of deployment. (Facts will be verified).
- k. A certificate to the effect that all security guards are paid monthly wages, not less than the minimum wages fixed by the government of Pakistan from time to time. Any violation at any stage in this regard will render the security company ineligible to work with PTA Zonal Office Lahore.

- 1. The bid prices shall not be in violation of minimum wages set by the Government of Pakistan, otherwise PTA Zonal Office Lahore has the right to reject any such bid or bids.
- m. The company should have the valid wireless license and should be able to provide walkie Talkie Sets on demand.
- n. Performance certificates by the major clients where your security company has been providing security services in the last two years.
- The company should have few licenses of automatic weapons and will provide at least 2 automatic weapons along with other weapons.
- 5. Weightage of Technical and Financial proposals will be 70% and 30% respectively. The bidder obtaining highest marks combining Technical and Financial proposals will be awarded the contract.
- 6. If two or more bidders obtain equal marks in Technical proposal, then the contract will be awarded to the one with lowest financial bid.
- 7. Salaries, perks, privileges and work hours of the guards will be governed strictly according to the government rules / regulations.
- 8. Compulsory remittance of EOBI, ESSI and insurance premium against each individual.
- 9. Evidence of remittance of insurance premium will be submitted on award of security contract.
- 10. Payment will be made on monthly basis by PTA Zonal Office Lahore through cheque after production of EOBI and ESSI receipts.
- 11. Security guards will be granted four days off per month.

- 12. The company will be responsible to get each guard medically examined by a registered medical practitioner and provide medical certificate. Similarly the company shall provide character certificates of each guard with verified antecedents.
- 13. Guards provided by the company should not be less than 25 years and not more than 50 years of age in case of guards. Bulky/overweight persons will not be accepted.
- 14. The guards should be trained and capable enough to handle the situation including but not limited to bomb blast, earthquakes and events of fire etc.
- 15. The company will provide a hand held metal detector and a vehicle search mirror at each location given at para-1 above.
- 16. Evaluation criteria is given in the technical proposal. Minimum threshold for qualifying in the technical proposal is 60%.

- 18. The successful bidder will have to provide either ex-servicemen or young energetic and trained civilian fully equipped and conversant with security performance and other requirements as mentioned in the security agreement.
- 19. During the contract, the firm will provide Security Services as per terms and conditions, to be settled later on in the shape of contract agreement, for PTA Zonal Office Lahore.
- 20. An agreement will be made between PTA and contractor on judicial paper of Rs. 100/-.
- 21. Availability of additional guards (if so required) will be ensured with in 24 hours.

- 22. Interested Security Companies may forward their proposals as per above instructions to the undersigned latest by 04 August 2015 at 1000 Hours.
- 23. PTA Zonal Office Lahore reserves the right to accept or reject the tender without assigning any reason as per PPRA rules.

1. **TERMS OF AGREEMENT**

- Execution. The security agency will be bound to execute the directives of the PTA.
- c. <u>Additional Guards.</u> In case PTA requires additional strength of guards, the security company shall provide the same according to requirement on the terms as agreed in the agreement on 24 hours notice.
- d. Salaries, perks, privileges and work hours of the guards will be governed strictly according to the government rules / regulations.

2. **GUARD SERVICES**

The Security Agency will be fully responsible to provide satisfactory services at **PTA** Zonal office Lahore

Energetic, smart, literate and healthy (preferably ex-serviceman) with complete uniform fully conversant with the security performance should be deployed at PTA Zonal Office and Rest House at Lahore in consultation with the security in-charge of the PTA. - (v) Actions like firing of weapons which are not intended for the purpose of defense and in violation of security company's license may lead to cancellation of the agreement besides involving other legal proceedings as required.
- h. The process of recruiting, interviewing and hiring employees of Company including any actions with respect to alleged discrimination of other employment practices are the sole responsibility of Security Company subject to what has been agreed in this agreement.

13. STATUS OF M/s -----SECURITY COMPANY LTD.

M/s_____ Security Company Ltd is a bonafide limited company working for its own account and acknowledges that this agreement does not confer upon it, or upon any individual employed by it, the status of any employee of the **PTA Zonal Office, Lahore** or that of any of its officers nor grants it, or any individual employed by it, any benefits not specifically provided for herein.

14. **SECURITY**

The Security clearance of all the employees of Company who are assigned to provide services under this agreement shall be the responsibility of M/s______ Security Company Ltd.

15. **TAXES**

Company shall be responsible for the taxes required to be paid by its under relevant law and for any necessary withholding of taxes from the salaries of employees of Security Company.

16. **RESTRICTION OF ASSIGNMENTS TAKE OVER**

a.	M/s Security Company Ltd shall not assign or sub-contract any of
	its duties or rights under this agreement, including but not limited to any
	benefit or interest herein or there under, any such assignment or sub-
	contracting by Company shall entitle the PTA Zonal Office, Lahore to
	terminate this agreement forthwith.

b. If Company shall make any arrangement with or assignment in favour of its creditors, or amalgamates with any other concern or is taken over, the PTA Zonal Office, Lahore shall be entitled to terminate this agreement forthwith upon notice.

17. **DISPUTES**

All questions, disputes, controversies arising directly or consequent to this agreement except matters, which are the sole discretion of **PTA Zonal Office**, **Lahore** under the terms of this agreement, shall be settled by mutual negotiations. Should such negotiations fail, the matter, as specified herein before subject to said exception shall be referred to arbitration by two arbitrators, one to be appointed by Company and the other by **PTA Zonal Office**, **Lahore** and on their recommendations the third arbitrator will be appointed, to decide whose decision shall be final and binding and not challengeable in law.

18. **EFFECT OF AGREEMENT**

This agreement embodies the entire understanding of the parties hereto on this subject and there are no commitments, terms, conditions or obligation, oral or written, express or implied other than those contained therein.

19. TERMINATION OF AGREEMENT

If M/s ______ Security Company breaches any terms and conditions laid down in this agreement and if such breach is not cured within thirty (30) days after receiving written notice from PTA Zonal Office Lahore specifying such breach in reasonable detail, PTA Zonal Office Lahore shall have the right to terminate this agreement by giving written notice thereof to the company, which termination shall go into effect immediately on receipt.

20. MODIFICATION OF AGREEMENT

Any amendment or modification of this agreement or additional obligation assumed by any of the party will be enforced only after mutual agreement of both the parties. No supplement, amendment, or modification of this Agreement shall be binding unless it is in writing and signed by all parties.
