1. Section 3.5 (b) may now be read as:

<p><b>7.2 PERFORMANCE BANK GUARANTEE</b>            The successful CONSULTANT shall submit a Performance Bank Guarantee (PBG) in the prescribed format for an amount equal to 10 percent of the bid/contract price in USD or equivalent Pak Rupees before signing the contract for carrying out the assignment. The PBG must be in USD, and the equivalent Pak Rupee provision is only to be applicable on the date of encashment of the PBG, if it has to be encased. On satisfactory completion of auction, this PBG shall be released. The Performa of PBG is enclosed at Annexure II.</p>	<p><b>7.2 PERFORMANCE GUARANTEE AND ITS CORRESPONDING BANK GUARANTEE</b>            The successful CONSULTANT shall submit a Performance Guarantee and its corresponding Bank Guarantee called Performance Bank Guarantee (PBG) in the format acceptable to the CLIENT for an amount equal to 10 percent of the bid/contract price in USD or equivalent Pak Rupees before signing the contract for carrying out the assignment. The PBG must be in USD, and the equivalent Pak Rupee provision is only to be applicable on the date of encashment of the PBG, if it is encashed. In the eventuality of the PBG being encashed, and the payment is made by the CONSULTANT or its Bank in equivalent Pak Rupees, the conversion rate to be used shall be the TT selling rate of USD on the date of encashment/payment, available on National Bank of Pakistan's website (<a href="http://www.nbp.com.pk">www.nbp.com.pk</a>). On satisfactory completion of auction, this PBG shall be released. The Proformas for the Performance Guarantee and its corresponding PBG are enclosed at Annexure II.G</p>
